



Review: To Address Social Risks, You First Need to Document Social Needs...


- Likely already are focusing on social determinants in some way given mission but without standardized data, it is harder to systematize and streamline this work into workflow
- Standardized data on social determinants of health is needed to inform care planning and population health management activities
- Standardized data on social determinants of health is also needed to demonstrate value of health centers and your focus on addressing nonclinical needs

Reducing Disparities Through Community Partnerships — The SDOH Academy



Brockton Community Health Center & Vicente Foods





In 2015, Brockton Neighborhood Health Center and Vicente's Tropical Grocery teamed up to develop adjacent sites to house a 13,600 SF health center and a 40,000 SF grocery store—through a \$22 million combined investment financed through NMTC.

Features of the collaboration:

- Wide variety of fresh foods from all over the world
- Nutritional guidelines and labels on shelves
- Focus on improving health of diabetic patients
- Teaching kitchen, staffed by dieticians and health workers
- Food preparation demonstrations and educational events
- Rewards system to encourage healthy choices
- City commitment to building new sidewalks and housing

<u>Community Partnerships to Serve Older Adults — The SDOH Academy</u>







CommuniCare Health Centers -San Antonio, TX



Population	Urban; 60% Hispanic; 40% African American; Public Housing
Impact of COVID in the area	Affecting individuals with public-facing jobs
Impact of COVID on the Health Center	Had to provide laptops to clinicians for virtual visits; Loss of employees
Major Challenges	Vaccine supply; team-based care education; Well-child visits.
Community Collaborations	Public Housing Authority
Promising Practices	Education; working with Public Housing Authority

Med Centro Health System -Ponce, PR



Population	Urban and Rural; Public Housing and Agricultural Workers
Impact of COVID in the area	Earthquakes impacted health services even before COVID
Impact of COVID on the Health Center	Decrease in cancer screening; increase in telemedicine and diabetes cases
Major Challenges	Vaccine supply; logistics and space; patients afraid of coming to the health center for primary care services;
Community Collaborations	Mobile Units; Local Agencies; Health Department; National Guard
Promising Practices	Certified nurses deliver vaccine; pharmacist went to the community



El Rio Community Health Center - Tucson, AZ



Population	Urban; Mostly Hispanic and Native Americans
Impact of COVID in the area	Language barriers for some Hispanic patients
Impact of COVID on the Health Center	Telemedicine services - affected preventive screening services and appointments for patients with diabetes and other chronic conditions
Major Challenges	Vaccine supply
Community Collaborations	State and local department of health; Churches
Promising Practices	Use of Promotoras; staff training and education; using EHR to communicate vaccine availability



Medical-Legal Partnerships (MLP): Health & Housing

MLPs embed lawyers as members of the health care team, creating:

- Healthier patients
- A stronger health center workforce
- Improved health equity

Legal Assistance

to address patients' social needs & help the health center workforce operate at "top of license"

Training

to build knowledge, capacity & skills that strengthen the health center workforce's response to SDOH

Clinic-Leve Changes

that leverage legal expertise to shape clinical practices to address many patients' needs at once

Policy Change Strategies

that advance healthy regulatory, administrative, & legislative policy solutions for whole



How Lawyers Help Address Patients' Social Needs

I-HELP™	How Lawyers Can Help
Income & Insurance	Food stamps, disability benefits, cash assistance, health insurance
Housing & utilities	Eviction, housing conditions, housing vouchers, utility shut off
Education & Employment	Accommodation for disease and disability in education and employment settings
Legal status	Assistance with immigration status (e.g. asylum applications); Veteran discharge status upgrade; Criminal background expungement
Personal & family stability	Domestic violence, guardianship, child support, advanced directives, estate planning




People's Community Clinic, Texas Legal Services Center & Texas Health Action MLP

The COVID-19 pandemic has led to:

- unemployment
 - evictions and foreclosures
 - threat to health and well-being

Partnership Solution:

The MLP team helped patients facing possible evictions and foreclosures and led efforts on a successful emergency rulemaking petition for a statewide directive around utility shutoff protection.

SOCIAL DETERMINANTS OF HEALTH

are broadly defined by the World Health Organization as the conditions in which people are born, grow, work, live, and age. These circumstances are shaped by economic and social policies, political systems, and social norms, and they contribute significantly to health disparities.



SOCIAL NEEDS

are the more immediate, individual needs that patients enter the health center with every day as a result of social determinants of health.



LEGAL NEEDS

are, simply put, the subset of social needs that have legal solutions. The distinction in this guide is made to help health centers understand where lawyers can be helpful*.

*Table 1 on page 8 highlights a variety of legal needs that MLP lawyers can address for patients.

Resource Showcase: Developing Cross-Sector Partnerships

Medical Neighborhood "Maps" could look like:

- 1. Circle diagrams with the patient/population in the center and partners listed on spokes
- 2. Excel lists of partners with relevant contact information
- 3. Noted on patient care plans in the EHR
- 4. A bulletin board in the health center







Levels of Partnership

- Networking: Information sharing between groups
 - Coordinating: (in addition) Aligning activities to meet a common goal
 - Cooperating: (in addition) Sharing resources or space through a written contract
 - Collaborating: (in addition) Enhancing capacities through seeking mutual feedback



Memorandums of Understanding (MOUs)

- 1. Identify purpose: (example: *To facilitate individuals' consistent participation in health-enhancing activities*)
- 2. Identify principle: (example: Focus on patient and family needs)
- 3. Defining common terms (example: elderly vs older adult)
- 4. Define funding and duration How will partnership continue if the funds are depleted?



Evaluating Partnerships

Important questions to ask:

- 1. Who is the evaluation for?
- 2. What are their priorities?
- 3. What do they want to know?
- 4. What targets does the partnership want to reach?
- 5. When do you want to reach those targets?



Case Study: Public & private partnership between Alivio Medical Center, The Resurrection Project, and City of Chicago, Dept of Family Support Services, Senior Area Agency on Aging

Resulted in: Casa Maravilla, a 7,000 sq. ft. senior housing building in Chicago's Pilsen neighborhood that has 73 independent apartments for adults age 55 and older.



Casa Maravilla: Partnership Stages

<u>Nurturing</u>: Community activists seeking affordable housing options for seniors; land purchase; creation of senior center

<u>Maintaining</u>: Extended care to over 6,000 older adults; monthly wellness programs

<u>Evaluating</u>: Bilingual/bicultural staff; screening for eligible services; connections with community youth; construction of new building


