

## Before

- Information about risk
- Resources to prepare for disaster
- Lack of inclusion in disaster preparedness efforts
- Access to communication platforms



# During

- Housing risk
  - ✓ Homes more vulnerable
  - **✓** Location more vulnerable
- Access to resources to mitigate the effect (i.e. air conditioners, generators)
- Economic loss
  - ✓ Resources more tied up in material goods than in less tangible savings



### After

- · Finding and obtaining aid
- Lack of access to housing
- Food insecurity
- Stress, anxiety, depression associated with lack of resources and trauma
- Access to healthcare and other services
- Role in clean-up and other services that allow communities to "return to normal".


#### Blame workers

## Issues experienced by essential workers during a

- Working conditions
  - Lack of sick leave
  - Fear of employer retaliation
  - Lack of protective equipment
- Access to public benefits, including emergency benefits (housing, food, medical care)
  - Information
  - Eligibility
  - Language

## **Legal Protections**

- COVID-19 Emergency Temporary Standard
  - CA & VA (all workers)
  - WA, OR, MI, WI (agricultural workers)
- California Wildfire Standard
- Other occupational safety and health protections (agriculture)
  - Field Sanitation Standard (OSHA)
  - Worker Protection Standard (EPA)
  - Heat Illness Standards (CA, WA, MN)

I-HELP™		How Lawyers Can Help
Income & Insurance	\$	Food stamps, disability benefits, cash assistance, health insurance
Housing & utilities		Eviction, housing conditions, housing vouchers, utility shut off
Education & Employment		Accommodation for disease and disability in education and employment settings
Legal status		Assistance with immigration status (e.g. asylum applications); Veteran discharge status upgrade; Criminal background expungement
Personal & family stability		Domestic violence, guardianship, child support, advanced directives, estate planning



### **Outreach Role**

- Facilitates access to primary care
- Provides health education
- Provides case management
- Connects communities to Social Services
- Helps inform Health Care delivery to be culturally responsive
- Advocate on behalf of underserved populations

# Outreach Workers and Community Health Workers Disaster Preparedness

- Emergency Preparedness Planning should include outreach and community health workers.
- Identify Partnerships, linkages and collaborations.
- Prepare for Communications and Information Sharing
- These roles can document the work they do and are included in evaluation of emergency drills, projects, and actual emergency assessments.4

# Community Health Worker

A Community Health Worker is a trusted member of their community, who builds individual and community capacity by increasing health knowledge and self-sufficiency through a range of activities such as outreach, community education, informal counseling, social support and advocacy.














- > Types of Emergencies
  - Natural disasters
  - Pandemics
  - Chronic diseases
  - Foodborne illness outbreaks
  - Non health emergencies

CHWs are invested in their communities and can help the community return to a sense of normalcy after a disaster occurs.

- o Before/ Getting ready
  - Prepare a plan of action
  - Offer resources (sand bags, shelter/housing, etc)
  - Collect census information
  - Mobilizing communities responses
- o During
  - Serve as a relay point for information
  - Connect community with key partners
- After/ Recovery
  - Screening and assessing
  - Support groups
  - Provide information
  - Connect community with key partners
